23	I acknowledge that if I fail to submit a certificate of or declare the residents' tax payment of my household by the deadline designated by the City, my nursery school fees will be charged at the highest level.	<input type="checkbox"/>
24	I understand that, because nursery school fees are determined based on the amount of municipal graded income tax of each household, I need to report the tax even if I have no income.	<input type="checkbox"/>
25	The duration of enrollment to the nursery school permitted for the reason of "Seeking employment" is limited to three months. If you do not submit documents such as an employment certificate during this period, your child will not be allowed to attend the school. The duration of enrollment to the nursery school permitted for the reason of "childbirth" is from two months (four months, for multiple births) before the month in which the childbirth is expected until the end of the month in which the 57th day from the day of childbirth falls. 26	I understand that the child must be withdrawn from the nursery school if: (1) the child is enrolled in a kindergarten, international school, company-led childcare services, etc.; (2) either of the parents/guardian can take care of the child at home because of retirement or other reasons; (3) the family moves out of the City and the parents/guardian do not work in the City; or (4) the child is absent from the nursery school for more than 3 months (excluding cases where the child is absent from the nursery school due to the child's illness or injury, or due to the birth of the child's sibling) (5) one of the parents/guardians takes childcare leave again from the beginning of the month to the end of the month for the child to be enrolled	<input type="checkbox"/>
27	After moving out, the child can continue to stay in the facility only if any of the parents/guardians continue to work in Minato City and there is an application from the municipality to which the family has moved during the month the family has moved out (except, however, during childcare leave, while seeking employment, or after receiving a preliminary job offer or home-visit type childcare services). When the child will be absent from nursery school for more than one month from the beginning of the month due to the birth of younger child, the parents/guardians may be exempted from paying childcare fees if they apply by the end of the previous month with a copy of their Boshi Techo (Mother and Child Health Handbook) attached.
