Certification and Enrollment Applications			
1	We read the "Nursery School Enrollment Guide" before applying, and made sure to understand the content.		
2	We have gathered all documents required for enrollment application before submitting them. There are no falsehoods in the content (applications will be invalid in the event that falsehoods are discovered).		
3	Enrollment application was made only after checking that we fall under the reasons for requiring childcare.		
4	The desired nursery school was determined in order of preference for attendance, irrespective of the vacancy status, after thoroughly considering the distance and time from home to the nursery school.		
5	If there are any changes to work or family composition, or other application details after application, we will promptly contact the responsible Regional City Office and will submit the necessary documents (We understand that if not submitted by the deadline it will not be reflected in the total index.		
6	If our resident tax information cannot be confirmed, it may disadvantage our priority ranking under the Minato City childcare utilization adjustment criteria. (If resident tax has not been declared, declaration is necessary.)		
7	There may be confirmations with guardians or workplaces by telephone or home visit regarding the content of submission documents.		
8	If changes to the content of the application are discovered after placement or enrollment decision, the placement or enrollment decision may be cancelled.		
9	If the need for childcare ceases after application we will promptly submit a Nursery School Application Withdrawal Form.		
10	If the guardian circumstances are unclear from submitted documents and additional documents are requested, we will submit them by the designated deadline.		
11	The application form is valid until the end of the fiscal year containing the desired enrollment month. However, in the case of job seeking, childbirth, or school attendance, the validity is limited to the certification period. If we continue to desire enrollment from April of the following fiscal year, we will need to reapply.		
12	If simultaneously applying for enrollment for January to March 2025 and April 2026, and placement/enrollment is made in January to March 2025, April 2026 enrollment will not be subject to utilization adjustment. (excluding home-visit childcare services for children on waiting lists).		
Utiliza	tion Adjustment		
13	The index is decided at the utilization adjustment meeting.		
14	We understand that, based on the Minato City childcare utilization adjustment criteria, placement offers are made to applicants with higher total household indexes, in order, for nursery schools with available vacancies.		
15	If we receive enrollment placement, the enrollment month cannot be changed.		
16	If the doctor's health checkup and nursery school interview are not completed by the end of the month before the month of enrollment, the placement will be cancelled.		
17	If we wish to decline the placement, we will submit a Placement Decline Form within the designated period. If a first preference nursery school is declined, or a Placement Decline Form is submitted after the deadline, no waitlist notice will be issued.		
18	If not placed, a waitlist notice will be sent only for the initial application period. During the validity period of the application, it will be subject to the adjustment meeting.		
19	Utilization adjustment may be carried out for children with issues such as disabilities, illnesses, or developmental delays, etc., depending on the situation at the applied for nursery school. Failure to declare the above at the time of application may result in cancellation of placement if discovered afterward.		
After E	nrollment		
20	If there are changes to certification content, refer to the leaflet distributed after enrollment and contact the responsible Regional City Office or nursery school and submit the "Application to Change Application for Certification of Children's Education and Childcare Benefits" along with the necessary documents.		
21	If no longer falling under the reasons requiring childcare, this will be deemed a withdrawal.		
22	The submission of a Current Status Report is required once per year to confirm the reason for requiring childcare. The City will notify you of the submission method. Be sure to submit any necessary documents by the deadline. If the reason for requiring childcare cannot be confirmed, use of the nursery school will no longer be possible.		
23	If the resident tax declaration or related documents required to determine the household category are not submitted by the deadline specified by the City, the category will be determined at the highest level.		
24	The categories are determined based on the municipal resident tax income portion, so even those without income must submit a municipal resident tax declaration.		
25	The enrollment period when "job seeking" is the certified reason shall be for up to three months. If documents such as an employment certificate are not submitted during this period, it shall be deemed a withdrawal. The enrollment period when "childbirth" is the certified reason shall be from two months prior to the scheduled birth month (4 months in the case of multiple births) to the end of the month containing the 57th day from the next day of birth. The enrollment period when "school attendance" is the certified reason shall be until the end of the period of school attendance (graduation).		
26	We understand that falling under any of the following will be deemed withdrawal. (1) When enrolled in a kindergarten, international school or company childcare service, etc. (2) When becoming able to provide childcare at home due to retirement, etc. (3) When moving out of Minato City and having no workplace within Minato City (4) When absent from the nursery school for more than 3 months (However, this shall not apply to illness or injury of the enrolled child, or the birth of a younger sibling) (5) When one of the guardians takes childcare leave again to take care of the applicant child from the start of the month until the end of the months		
27	Continued enrollment after moving out of the City is only possible when either guardian has a workplace in Minato City, and when application is made from the municipality of the move-out, during the month of moving out (however, it will not be possible to continue during childcare leave, job seeking, job offer, and home-visit childcare services). 28	We will certainly pay the extended childcare fees by the designated deadline when utilizing extended childcare.
