

## When You Want Temporary Care for Your Child

## **Temporary Childcare**

Parents/guardians who usually care for their child in the home but are facing temporary difficulties in doing so can receive temporary childcare. Note that some certified nursery schools, baby hotels, etc., also provide temporary childcare. Each of these facilities have a different capacity. See the Minato City official website for details.

## **Temporary Childcare (Public Nursery Schools)**

## **Temporary Childcare (Small-Scale Childcare Services)**

In April 2021, small-scale childcare services will begin providing temporary childcare to parents/guardians who require it due to employment with short working hours, etc., utilizing the vacant spots in their facilities.

## Program for Dispatch-type (Babysitter) Temporary Childcare

Child-rearing Square "Ai-port"5786-3250

Support members provide temporary on-site childcare (babysitting) at the member's home, with no restrictions as to the reason behind parents'/guardians' use of the service (injury/illness, social reasons, time to refresh themselves, etc.).

Eligibility: 7 days old - 6th-year elementary school student / Must reside in the City

**Support Members:** The support members who provide the childcare are people who have completed the Training for Child-rearing Supporters program.

How to Use: This is a membership service based on registration by users and support members. To use the service, you must participate in the Member's Registration Information Session (reservation required), held at Ai-port (2-25-1 Minami-aoyama). Following the information session, you will be asked about your household circumstances, your child, etc., after which you will be introduced to a support member.

**Content:** Temporary childcare consists of the following.

- · Taking the child to and from nursery school, kindergarten, pupils' clubs, elementary school, etc.
- Childcare for infants 7-28 days old (newborn childcare)
- Childcare for children recovering from illness (post-illness childcare)

Fee: From 900 yen per hour

\*Fees vary depending on the time of use, the type of childcare provided (temporary childcare, post-illness childcare, newborn childcare), etc.

## **Twilight Stay**

Minato Child-rearing Supporting Center "Pokke"6435-0411

Provides childcare for parents/guardians who reside in the City, and are unable to care for their child in the evening due to work, etc.

Age of Eligibility: 6 months old - 3rd-year junior high school student

Capacity: 10

Hours: 5:00 PM - 10:00 PM

Closed: New Year's holiday, irregular holidays

Fees

Mon - Sat: 2,000 yen per day Sun / Holidays: 2,500 yen per day

\*Additional dinner fee.

\*Additional transportation fee if you wish to have the child picked up from a childcare facility/school in the city.

#### When to Register:

From 9:00 AM on the 1st of the previous month to 12:00 PM two days before you wish to use the service (excludes Sundays, national holidays, New Year's holidays)

\*Advance registration and interview required.

## Short Stay for Infants and Young Children

We offer childcare including overnight stays when the parent cannot care for their child due to work, childbirth, illness, etc.

\*To use the service, you will need to submit documents proving you fulfill the usage requirements.

## Komusubi - Child-rearing Support Program

The child-rearing support program Komusubi is run by the Family Support Center, which connects people who need help with childcare (user members) to people who can provide that help (cooperating members), and is dedicated to the healthy development of children throughout the region.

## **Eligibility:**

Those who live or work in Minato City, and who require childcare support

#### **Eligible Children:**

0 years old - 6th-year elementary school students

#### **Support Fee:**

800 yen per hour

(For siblings, the fee from the second child onward is set at half-price, or 400 yen)

User members will also cover the cooperating members' transportation costs, costs for the child's meals/snacks, etc.

\*In general, user members should pay the support fee directly to the cooperating member upon each instance of use.

## **Days/Hours:**

Mon - Sun (including national holidays, New Year's holiday) / 7:00 AM - 8:00 PM

\*Generally up to 2 hours per instance.

#### Location:

Home of the user member or cooperating member (Could also be nearby Children's Hall, public park, etc.)





#### **Details of Activities:**

Dropping off/picking up children at childcare facilities, providing out-of-hours childcare, providing childcare when the parent/guardian has to go to the hospital or leave the home for other reasons, etc. \*The user member, child, and cooperating member will arrange a meeting in advance in order to discuss points of note when it comes to spending time with the child, introduce the cooperating member to staff at the child's childcare facility, etc. (An advisor or sub-leader will be present for this meeting.)

## **Member Registration**

Both user members and cooperating members must register in advance (registration is free).

User members should generally contact the office mentioned above in advance before coming in to complete the registration procedures. (About 30 minutes, including explanation)

Hours: 8:30 AM - 5:15 PM (closed on weekends, national holidays, New Year's holiday)

Home-visit registration is also offered to those who find it difficult to visit the office due to special circumstances, etc.

\*Cooperating members will be allowed to register once they have completed the Minato City Training for Child-rearing Supporters program. Contact the office for more details.

## Subsidies for Use of Babysitters for III Children and Children Recovering from Illness © Childcare Facilities Support Subsection,

Nursery School Section 3578-2429

The cost of hiring babysitters for sick children and post-sickness childcare is partially subsidized for parents or guardians who recruit them during periods when it is difficult to send their children to nursery schools and elementary schools due to the child's condition.

## **Eligibility:**

Children from 57 days old to 6th-year elementary school students who have been recognized as needing childcare (No. 2 or No. 3 Certification), who are currently enrolled in a licensed nursery school, certified children's garden (kodomo-en), local childcare center, Minato City nursing facility, Tokyo-certified nursery facility, unlicensed childcare facility that has submitted documents to the prefecture and/or municipality, Minato Child-Care Support (regular use), and/or after-school children's club (Pupils' Club).

## **Subsidy:**

Maximum of 50,000 yen per year. 50% of the fees are subsidized, for a maximum service fee of 100,000 yen.

\*Households that receive public welfare assistance or are exempt from resident tax receive a maximum annual subsidy of 100,000 yen.
