

# Information regarding the COVID-19 Vaccination



## ■ To individuals who have moved out of Minato City

If you have moved out of Minato City as of the date of your vaccination, you cannot use the COVID-19 Vaccination coupon issued by Minato City. Please contact your new municipality for your new COVID-19 vaccination coupon to be issued.

## ■ To individuals who have moved to Minato City

Those who have moved to Minato City **need to apply for a vaccination ticket in order to receive their COVID-19 Vaccination.** However, if you have already been vaccinated with the number of vaccinations decided by the local government before moving in or if you do not wish to be vaccinated, then applying is unnecessary. **Please confirm the required documents in order to be issued with Minato City COVID-19 Vaccination coupons and then submit the application as followed.**

### 1 Required Application Documents

- ① An application to have a COVID-19 Vaccination coupon Issued 【Required】  
(You can download it from Minato City website)
- ② A copy of an identity verification document (i.e., driver's license, health insurance card, etc.) 【Required】
- ③ A copy of proof of vaccination or vaccination record (For individuals who have completed their first/second COVID-19 shots)  
\* If a proxy/representative is applying to have a COVID-19 Vaccination coupon issued, then both the proxy/representative who is applying and the vaccine recipient must provide a copy of their identity verification documents (i.e., driver's license, health insurance card, etc.).

### 2. Application Method

Please prepare the required documents and then apply by mail. Applying via the Internet is also possible. Please refer to the Minato City website for details.

## VACCINATION TARGET

- ◆ For the first and second shot of COVID-19 vaccination... Those who are aged 5 years and older
- ◆ For the third shot of COVID-19 vaccination... Those who are aged 12 years and older who have past 5 months from the second vaccination
- ◆ For the fourth shot of COVID-19 vaccination... Those who fall under the following A or B and have past 5 months from the third shot
  - A: Those who are aged 60 years and older
  - B: Those who are 18 to 59 years old and have the underlying disease indicated by the government.
